This agreement confirms the reservation to the stallion **RAMIRO B** (hereinafter referred to as the “Stallion”) for the 2021 breeding season by the owner or lessee of the mare whose signature appears below (hereinafter referred to as the “Owner”). Owner hereby agrees to breed the mare _____ with the registration No # _____, registered in the following stud book _____, (referred to as the “Mare”) Breeding will be done by using the **frozen semen** supplied by Stallion AI Services (hereinafter referred to as “SAIS”) whilst available. Should fresh or chilled semen for any reason not be available, then frozen semen would be supplied instead.

Terms and conditions:

- This semen is for use within conventional Artificial Insemination or Embryo Transfer cycles only and **use of the semen for ICSI, or any other advanced reproductive techniques is prohibited.**
- All the semen purchased under this contract must be used on the mare nominated above
- Breeding’s being purchased for use in Embryo Transfer or advanced breeding programs are entitled to one pregnancy only. If multiple pregnancies are achieved from the same flush or procedure, the **full stud fee** will be charged for each additional pregnancy on confirmation of a heartbeat scan
- The stud fee **does not** include semen distribution & collection fees, please request shipping prices separately.
- This is a Non-refundable Contract. You are strictly prohibited from reselling straws.
- **Not under any circumstances must doses be split**

Should the mare not be in foal it is the mare owner's responsibility to provide a signed veterinary certificate to prove this or the full stud fee will be due as stated above.
